**1. Requirements** - You must meet all of the following: A. This business operates on a full-time basis B. You have a functioning professional website or a brick and mortar store C. Your business is reasonably focused and marketed as a radio control hobby store.

**2. Verification** - Please attach all of the following to your application:

- A. Three current pictures representative of your store's hobby inventory.
- B. One picture of your storefront or business' operating area. Any location other than a conventional business, strip center, or mall will require special explanations.
- C. A link to your website or store business listing (yellow pages)

Our staff will review your application and you will be notified about acceptance as quickly as possible. An initial minimum order value will be placed on all new accounts and will be discussed after the application has been reviewed. Accounts that do not maintain a minimum of \$250 net orders every 60 days are subject to review and may be asked to reapply.
